About the Role

As a member of our Quality Assurance (QA) team reporting to the Quality System Specialist, the *Warehouse Quality Control Inspector* monitors and ensures compliance with quality system requirements as it relates to inbound and outbound activities throughout the warehouse.

Duties & Responsibilities

- Reviewing inbound and outbound materials to ensure all required paperwork is included (Bill of Lading (BOL), Certificate of Analysis (CofA), Certificate of Conformance (CofC), Notice of Arrival (NOA), Toxic Substance Control Act (TSCA) certificate etc.) and following up with appropriate individuals to obtain missing documents;
- Notifying suppliers and internal stakeholders of quantity discrepancies for product received and/or product damaged in transportation and issuing incident reports for any non-conforming items;
- Informing lab personnel of incoming chemicals and assisting with the release of chemicals;
- Sampling incoming packaging material and labels, verifying quantity and coordinating physical and/or electronic release;
- Performing daily audit of warehouse and segregating any non-conforming (i.e. damaged products);
- Tracking and reporting the status of non-conforming products to management upon full closure;
- Coordinating all inspections, rework and/or disposal activities related to incoming materials or goods damaged internally.
- Monitoring inventory movement within the warehouse to ensure product is tracked and accounted for accuracy;
- Other projects and tasks, as assigned.

What do you need to succeed?

- One (1) to two (2) years of experience working in an ISO certified warehouse;
- Strong verbal and written communication skills;
- Demonstrated problem solving and reporting skills;
- Ability to work independently;
- CQI certification is considered an asset;
